The undersigned is fully aware of the risks inherent in running or walking conducted on National Forest System (NFS) lands, including but not limited to tripping, falling, physical exertion, environmental exposure, being in the presence of other individuals or animals, and possible exposure to viral transmission including COVID-19. The undersigned understands that the possible consequences of participating in this activity include, but are not limited to sprained ankle, broken bones, heat exhaustion, heat stroke, frostbite, other medical conditions, viral transmission including COVID 19, and possibly even death. The undersigned has the necessary skills and ability to participate in running or walking races conducted by Calico Racing, LLC on NFS lands and assumes full responsibility for bodily injury, death, and loss of personal property as a result of the undersigned's negligence in participating in running or walking races conducted by Calico Racing, LLC on NFS lands, except to the extent that the bodily injury, death, or loss of personal property may be due to the negligence of Calico Racing, LLC. The undersigned also agrees to abide by the rules or instructions given to the undersigned either verbally or in writing by Calico Racing, LLC. The undersigned further understands that Calico Racing, LLC reserves the right to refuse to allow any person to participate in this activity who is judged to be incapable of meeting the rigors and requirements of participation. The undersigned has read, understood, and accepted the terms and conditions in this agreement. The undersigned's participation in running or walking races conducted by Calico Racing, LLC on NFS lands is purely voluntary, and the undersigned elects to participate in spite of the risks.

In consideration for allowing my participation in the Running with the Devil 100K, 50 Miler, 50K, Marathon, 1/2, 10K, & 5K and other valuable consideration, I, the below signed, for myself, my heirs, assigns, executors, next of kin, successors and administrators, intending to be legally bound thereby, hereby RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE Joyce Forier, Calico Racing, LLC; The City of Las Vegas; The City of Henderson; Boulder City; Blue Diamond; The National Park Service; U.S. Department of Agriculture; United States Forest Service; The Bureau of Reclamation; The Bureau of Land Management; Lincoln County; Clark County; The Little A'le'Inn; USATF; Red Rock Conservation Area; Nevada Highway Patrol; Nevada Department of Transportation; The United States of America; and The United States Government, its officers, employees, volunteers, and agents, and any and all persons or entities associated with the Running with the Devil 100K, 50 Miler, 50K, Marathon, 1/2, 10K, & 5K including but not limited to the race promoters, race officials, sponsors, volunteers, involved government entities and all the representatives, successors and assigns of the aforementioned parties from any and all liability, claims, demands, suits, actions and/or causes of action whatsoever for any loss, damage, or injury, including death, that may be sustained by me, or to any property belonging to me, while participating in the Running with the Devil 100K, 50 Miler, 50K, Marathon, 1/2, 10K, & 5K or arising out of or resulting from my participation in the Running with the Devil 100K, 50 Miler, 50K, Marathon, 1/2, 10K, & 5K or incurred while in, on or upon the premises/property where the activity is being conducted or in transportation to and from said premises/property, irrespective of WHETHER THE LOSS, DAMAGE, OR INJURY, INCLUDING DEATH WAS CAUSED BY THE NEGLIGENCE OF THE AFOREMENTIONED RELEASED PARTIES, or otherwise. I further agree to INDEMNIFY AND HOLD HARMLESS the aforementioned released parties from any loss, liability, damage, costs, including court costs and attorney's fees, that may be incurred due to my participation in the Running with the Devil 100K, 50 Miler, 50K, Marathon, 1/2, 10K, & 5K, WHETHER CAUSED BY THE NEGLIGENCE OF THE AFOREMENTIONED RELEASED PARTIES, or otherwise. Further, any disputes arising under this contract will be governed by the laws of the State of Nevada and heard before an arbitrator selected by Joyce Forier.

I attest that I am physically fit and have trained sufficiently and educated myself appropriately for this event. I understand that participating in this event and under these conditions is dangerous and I enter this event accepting the risks.
