In consideration for allowing my participation in the Extraterrestrial Full Moon Midnight Marathon, 1/2, 10K, 5K & 51K and other valuable consideration, I, the below signed, for myself, my heirs, assigns, executors, next of kin, successors and administrators, intending to be legally bound thereby, hereby RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE Joyce Forier, Calico Racing, LLC; The City of Las Vegas; The City of Henderson; Boulder City; Blue Diamond; The National Park Service; U.S. Department of Agriculture; United States Forest Service; The Bureau of Reclamation; The Bureau of Land Management; Lincoln County; Clark County; The Little A'le'Inn; USATF; Red Rock Conservation Area; Nevada Highway Patrol; Nevada Department of Transportation; The United States of America; and The United States Government, its officers, employees, volunteers, and agents, and any and all persons or entities associated with the Extraterrestrial Full Moon Midnight Marathon, 1/2, 10K, 5K & 51K including but not limited to the race promoters, race officials, sponsors, volunteers, involved government entities and all the representatives, successors and assigns of the aforementioned parties from any and all liability, claims, demands, suits, actions and/or causes of action whatsoever for any loss, damage, or injury, including death, that may be sustained by me, or to any property belonging to me, while participating in the Extraterrestrial Full Moon Midnight Marathon, 1/2, 10K, 5K & 51K or arising out of or resulting from my participation in the Extraterrestrial Full Moon Midnight Marathon, 1/2, 10K, 5K & 51K or incurred while in, on or upon the premises/property where the activity is being conducted or in transportation to and from said premises/property, irrespective of WHETHER THE LOSS, DAMAGE, OR INJURY, INCLUDING DEATH WAS CAUSED BY THE NEGLIGENCE OF THE

I voluntarily assume full responsibility for any risks of loss, property damage or personal injury, including death, that may be sustained by me, or any loss or damage to property owned by me, as a result of my participation in the Extraterrestrial Full Moon Midnight Marathon, 1/2, 10K, 5K & 51K, WHETHER CAUSED BY THE NEGLIGENCE OF THE AFOREMENTIONED RELEASED PARTIES, or otherwise.

Further, any disputes arising under this contract will be governed by the laws of the State of Nevada and heard before an arbitrator selected by Joyce Forier.

I attest that I am physically fit and have trained sufficiently and educated myself appropriately for this event. I understand that participating in this event and under these conditions is dangerous and I enter this event accepting the risks. I agree that I will wear reflective clothing and wear a headlamp or carry a handheld flashlight. I understand this is a night race and is along an "open range" highway where animals may be present.

I understand that while participating in this activity, I may be photographed. I agree to allow my photo, video or film likeness to be used for any legitimate purposes by the aforementioned released parties including but not limited to Joyce Forier and Calico Racing, LLC.

If any provision or provisions of this Agreement shall be held to be invalid, illegal, unenforceable or in conflict with the law of any jurisdiction, the validity, legality and enforceability of the remaining provisions shall not in any way be affected or impaired thereby. In signing this release, I acknowledge and represent that I have read the foregoing Waiver of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this release for full, adequate and complete consideration fully intending to be bound by the same.
