In consideration for allowing my participation in the Purple Run 5K, 10K, and ½ Marathon and other valuable consideration, I, the below signed, for myself, my heirs, assigns, executors, next of kin, successors and administrators, intending to be legally bound thereby, hereby RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE Joyce Forier, Calico Racing, LLC; The City of Las Vegas; The City of Henderson; Boulder City; Blue Diamond; The National Park Service; U.S. Department of Agriculture; United States Forest Service; The Bureau of Reclamation; The Bureau of Land Management; Lincoln County; Clark County; Clark County Parks and Recreation, The Little A'le'Inn; USATF; Red Rock Conservation Area; Nevada Highway Patrol; Nevada Department of Transportation; The United States of America: and The United States Government, its officers, employees, volunteers, and agents, and any and all persons or entities associated with Purple Run 5K, 10K, and ½ Marathon including but not limited to the race promoters, race officials, sponsors, volunteers, involved government entities and all the representatives, successors and assigns of the aforementioned parties from any and all liability, claims, demands, suits, actions and/or causes of action whatsoever for any loss, damage, or injury, including death, that may be sustained by me, or to any property belonging to me, while participating in the Purple Run 5K, 10K, and ½ Marathon or arising out of or resulting from my participation in Purple Run 5K, 10K, and ½ Marathon or incurred while in, on or upon the premises/property where the activity is being conducted or in transportation to and from said premises/property, irrespective of WHETHER THE LOSS, DAMAGE, OR INJURY, INCLUDING DEATH WAS CAUSED BY THE NEGLIGENCE OF THE AFOREMENTIONED RELEASED PARTIES, or otherwise. Further, any disputes arising under this contract will be governed by the laws of the State of Nevada and heard before an arbitrator selected by Joyce Forier.

I attest that I am physically fit and have trained sufficiently and educated myself appropriately for this event.
